### Improving the functioning of the European Union building on the potential of the Lisbon Treaty



*Rapporteurs:* Mercedes Bresso (S&D) and Elmar Brok (EPP-DE)

The draft report and the 888 amendments tabled will be voted during this meeting. The rapporteur is presenting about 60 draft compromise proposals covering the great majority of paragraphs.

In their draft report the rapporteurs are examining the yet unused possibilities offered by the Lisbon Treaty to tackle the challenges that the Union is currently facing, by adapting its institutional structure, enhancing its democratic accountability, deepening the Economic and

Monetary Union, completing the internal market and furthering joint efforts in the fields of External Action and Justice and Home Affairs.

### **Possible evolutions of and adjustments to the current institutional set-up of the European Union**



*Rapporteur:* Guy Verhofstadt (ALDE - BE)

The draft report was presented during the AFCO meeting of 12 July 2016. Afterwards, some thousand amendments were tabled. Almost ninety compromise amendments were then presented by the rapporteur. The vote will take place during this meeting.

The draft report by Guy Verhofstadt focuses on the following issues for reform of the Treaties:

\*Ending "Europe a la carte" ("variable geometry", type of "associate status");

\*The withdrawal of the UK from the European Union;

\*New Economic governance (convergence code, fiscal capacity, debt instrument, Fiscal compact, ESM treasury facility, EU Finance Minister, ECB, ECJ);

\*New challenges (energy, migration, terrorism);

\*Strengthening Foreign Policy (EU Foreign Minister, ECJ - CFSP, European Defence Union);

\*More democracy, transparency and accountability (Commission size, VPs, top candidates, European party lists, reallocation of seats, Council of the States, special Law Council, composition of Council configurations, Eurogroup, Eurozone arrangements, national parliaments, legislative initiative, EU budget and budget control, Right of Inquiry, and treaty ratification procedure);

\*Constituent process (treaty amendment, convention).
