Statute and funding of European political parties and European political foundations



Consideration of draft report

Rapporteurs: Mercedes Bresso (S&D) and Rainer Wieland (EPP)

After repeated insistence by the EP, the Commission finally presented, last September, a proposal for the revision of Regulation (EU, Euratom) No. 1141/2014 of 22 October 2014 on the statute and funding of European political parties and foundations.

Although this Regulation only became applicable at the beginning of the current year, Members had already identified some shortcomings in the legal text that required rapid correction in order to ensure transparency and effectiveness of the financing by the EU budget of European political parties. This notably concerns the level of co-financing, the possibility of multi-party membership of European Parliaments' Members, the reduced number of Members of the EP - one, in fact - required for funding, the financing of referendum campaigns or the introduction of a financial capacity criterion. The proposal of the Commission addresses some of these shortcomings.

The co-rapporteurs will be presenting their draft report, which in general welcomes the proposal of the Commission, although they propose several amendments to it.

AFCO will conduct its work on this proposal with a view that the new rules be applicable in due time before the next European elections in 2019.
