### **Proposal for a Regulation of the European Parliament on the detailed provisions governing the exercise of the European Parliament's right of inquiry**



*Consideration and adoption of a draft question for oral answer  
Rapporteur: Ramón Jáuregui Atondo (S&D)*

At the beginning of the legislature, the Parliament confirmed the proposal it had endorsed on 16 April 2014, when it adopted the David Martin Report. However, the Council and the Commission raised some points of disagreement and as a consequence, the Parliament provided a mandate for the Rapporteur to seek a compromise with those two institutions, since their consent is indispensable for Parliament to adopt the new regulation. In an attempt to overcome the institutional deadlock, the Rapporteur approached different Presidencies but, despite the Parliament's efforts, no substantial dialogue has developed at political level. The EP considers this very damaging for the correct exercise of its right of inquiry. Therefore, the Rapporteur has proposed to launch two questions for oral answer with debate, to the Council and to the Commission, on the EP proposal.

## **The implementation of the Treaty provisions concerning national Parliaments**

The aim of this report is to assess the use of the current mechanisms for the participation of national Parliaments in the European political process, as well as to determine possible improvements so that national Parliaments can take part more actively in the overall integration process. Likewise, it intends to examine the implementation of the political structured debate established between the Commission and national Parliaments.

## **The debate on the Future of Europe**



*Consideration of working documents*

On 20 June and 4 September, the Committee on Constitutional Affairs endorsed the coordinators' recommendations of 20 June and 13 July 2017 to draft a series of working documents on the constitutional aspects of the Future of Europe debate. The primary goal of these working documents is to provide the Committee with an evaluation of the White Paper and other documents published by the Commission, in light of the proposals formulated in the reports drafted by Mercedes Bresso and Elmar Brok and by Guy Verhofstadt, which were adopted in Plenary on 16 February 2017. These evaluations are accompanied by the observations of the different draftspersons. On 13 November, 6 working documents were presented and discussed. Today the two remaining working documents are on the agenda:

**- WD on the Commission reflection paper on "The deepening of the Economic and Monetary Union": Markus Pieper (EPP) and Mercedes Bresso (S&D) are the draftspersons;**

**- WD on the Structure and Working Method of the Council: Kazimierz Michal Ujazdowski (ECR) is the draftsperson with Claudia Tapardel (S&D).**
