## Amending Article 22 of the Statute of the ESCB and the ECB



Consideration of amendments
Rapporteurs: Gabriel Mato (EPP) and Danuta Maria Hübner (EPP)

In a joint meeting with the Committee on Economic and Monetary Affairs (ECON), MEPS will consider amendments of both committees to a planned Decision on amending Article 22 of the Statute of the European System of Central Banks (ESCB) and of the European Central Bank (ECB). Amending the Statute was first mentioned by the General Court in Case T-496/11, where it held that current framework does not empower ECB to adopt regulatory measures with regards to the clearing systems for financial instruments, in particular Central Clearling Counterparties. Amendment of the Statute of the ECB was therefore recommended by the ECB in June 2017 to provide it with a clear legal competence in the area of central clearing and to enable the Eurosystem to fulfil its mandate of conducting monetary policy and ensuring stability of the euro.

Under Article 129(3) of the Treaty on the Functioning of the European Union, Parliament and the Council can change a limited number of the Articles of the Statute following a recommendation from the ECB or a proposal by the Commission, following an ordinary legislative procedure

# Role of cities in the institutional framework of the Union



Adoption of draft report Rapporteur: Kazimierz Michał Ujazdowski (NI)

At the next meeting on 24 May, MEPs will vote on the adoption of a draft report on the "Role of cities in the institutional framework of the Union." This report, overseen by Rapporteur Ujazdowski, is AFCO's contribution to ongoing debates concerning the participation of cities in the EU decision-making process. It follows a resolution of the European Parliament on 9 September 2015 on the urban dimension of EU policies, in which Parliament formally recognised the growing relevance of cities in the institutional framework of the Union and acknowledged the important role that local authorities play in implementing European legislation. REGI committee is associated to this procedure.

Later in the day, AFCO will host a workshop on the EU-dimension of Brexit, focusing on the consequences for the EU of a future relationship agreement with the United Kingdom. This will include a presentation by experts of three research papers commissioned by Parliament's Policy Department for Citizens' Rights and Constitutional Affairs.

MEPs will then consider amendments to the Commission's proposed regulation on the European Citizens' Initiative, and the meeting will end with a presentation on the "European Added Value of the European Citizens Initiative", by Julian Plottka, Institute for European Politics.

# Rules and general principles concerning mechanisms for control by Member States of the Commission's exercise of implementing powers



Adoption of draft opinion Rapporteur for the opinion: Pascal Durand (Greens/EFA)

On 14 February, the Commission proposed changes to the rules and general principles concerning mechanisms for control by Member States of the Commission's exercise of implementing powers. The proposed changes are intended to deal with "no-opinion" situations in which the Commission is forced to take a decision on a draft implementing act without a majority opinion by the Member States.

AFCO decided in March to draft an opinion on the Commission's proposal and appointed Pascal Durand as rapporteur. During the meeting on 24 May, MEPs will vote on the draft opinion and the amendments tabled.

# Workshop: The consequences for the EU of the future relationship agreement with the United Kingdom



Presentation by experts

To put focus on the EU-dimension of Brexit, AFCO will hear from a panel of experts who will present three research papers commissioned by the Policy Department for Citizens' Rights and Constitutional Affairs.

This will include presentations by Federico Fabbrini, Director of the Brexit Institute at Dublin City University, on the institutional consequences of a "hard" Brexit; Franklin Dehousse, Professor of Law at the University of Liège, on the institutional consequences of a bespoke agreement based on a "distant" cooperation model; and Professor Michael Dougan, Jean Monnet Chair in EU Law at the University of Liverpool, who will discuss the consequences of an agreement based on a "distant" cooperation model.

# European citizens' initiative



Consideration of amendments Rapporteur: György Schöpflin (EPP)

Finally, MEPs will take the opportunity to consider over 194 amendments to the Commission's proposed regulation on the European Citizens' Initiative (ECI), a democratic instrument introduced with the Treaty of Lisbon in 2007 to offer citizens a greater say in EU agenda-setting and policy-making.

This discussion will be followed by a presentation on the "European Added Value of the European Citizens' Initiative", a study by Julian Plottka of the Institute for European Politics and commissioned by the European Parliamentary Research Service (EPRS).
