### Consent of the European Parliament to the draft European Council Decision establishing the composition of the European Parliament



Consideration and **adoption** of draft recommendation Co-rapporteurs: Danuta Maria Hübner (PPE) and Pedro Silva Pereira (S&D)

On 25 May 2018, the European Council sent a letter requesting Parliament's consent to the draft European Council Decision on the composition of Parliament. In its proposal, the European Council has not deviated in substance from Parliament's resolution of 07 February 2018 on the composition of the next European Parliament. The final text of the European Council decision needs to be approved at the European Council summit of 29 June 2018.

The draft has not received amendments and after voting in this extraordinary meeting of AFCO, the plenary vote will take place on Wednesday 13th June 2018.
